# **ESTS MISSION**

'Our mission is to improve quality in all aspects of our specialty: from clinical and surgical management of patients to education, training and credentialing of thoracic surgeons in Europe and worldwide.'

### How to become a member of ESTS:

Application is online at www.ests.org

You are required to obtain two Active ESTS Members to sponsor your application and you will need to enter their details during the application. (Trainee or provisional members are not eligible to sponsor applications).

Nursing and Allied Professional Members do not need to have sponsors in order to apply for membership.

Select the membership status that applies to you, including if you are a member of European Association for Cardio-Thoracic Surgery (EACTS), Canadian Association of Thoracic Surgeons (CaTS), or Society of Thoracic Surgeons (STS).

Trainee Membership is for a maximum of 'up to' 8 years from the date of graduation from Medical School.

Following approval of the Membership Committee, applicants will be provisional members until formally ratified by the General Assembly.

# **Active Membership Application:**

- Online Membership application (with 2 sponsors)
- English version of CV and list of any publications.

### Trainee Membership Application:

- Online membership application (with 2 sponsors)
- English version of CV
- Letter from your Head of Department confirming your Trainee Status including date training started and date due to complete.

### Nurse / Allied Professional

- Online membership application (no sponsors are required)
- Proof of status/qualification as a Nurse/Allied Professional
- Nursing and Allied Professional Members are not Members of the ESTS Charity for the purposes of the Companies Act. There are no voting rights and there is no eligibility to stand as ESTS Trustee/Director.

#### **Membership Process:**

Applications are reviewed by the Membership Committee. Review and decision takes approximately 7-10 days.

Once their decision is made you are notified by email and invited to pay your Membership

Fee for the current membership year. The membership year is 1 January – 31 December.

Membership fees are set at three levels according to the average per capita income in the country according to the World Bank.

Fees are paid annually (Invoiced in January and paid via ESTS website).

Trainee members who have completed their training will automatically become active members the following year. They will be notified and invoiced appropriately.

## Additional Option: dual membership with European Respiratory Society (ERS)

Members may also take advantage of dual membership with the European Respiratory Society (ERS) for an additional payment of 30 euros per year.

# What happens once the Membership Committee has made their decision?

- New members are put forward for ratification at the General Assembly at the annual ESTS Conference on General Thoracic Surgery and applicants are 'provisional' until then. Deadline for applications is 31 March. A two-third vote of those present and voting at the General Assembly shall be required to elect new members.
- Applications received after 31 March will be provisional until the following year's General Assembly. Provisional members are eligible for the benefits of membership.

# What happens after your Membership has been ratified?

- You will be able to download your membership certificate from your online member area.
- You will be given an ESTS lapel pin at the ESTS Annual Meeting.
- You will be notified annually when your Membership Fee is due for payment and also when you are changing from Trainee to Active status.
- Active members can sponsor new membership applications

# **Provisional Member Benefits include:**

- <u>EJCTS</u> when you have been accepted as a provisional member and following payment of the membership fee, the publishers, Oxford University Press, will contact you by email to organise your subscription for accessing the EJCTS online.
- Please note that the EJCTS is informed monthly of new members and so expect an administrative period for this process to be completed.
- Provisional members are eligible for reduced registration to the annual meeting, reduced registration to educational events and eligible for joining the ESTS Database.

## How can I discontinue my Membership of ESTS?

Members of any category may resign at any time by informing the Secretary General.

# What happens when I retire from active practice?

Senior Membership is reserved upon request after the age of 65 for active members who retire from active clinical practice but who wish to remain members of the Society. There is no fee for Senior Membership but online access to the EJCTS would be discontinued.

## What is an 'Honorary Member'?

Honorary Membership is reserved for distinguished persons who have promoted the development of thoracic surgery in an outstanding manner. Honorary members are proposed by ESTS Board of Directors and appointed by two-thirds of the voting members in the General Assembly. Election to Honorary Membership is for life.
